Terms:

- **Driveways will be cleared of snow once per 24-hour period after there is accumulation of four or more inches.** We generally go out on the route after the Town of Truckee plows have cleared the streets. ***There is no set route or time specified to do snow removal.***
- Staking of the driveway will be included as part of our service. This helps determine the depth and width of the area to be cleared of snow. The area to be cleared will be the paved driveway from the street level up to 24 inches from your garage door.
- Although we accept responsibility for damages caused by driver error, Acme is not responsible for damages due to unseen obstacles and objects, or for driveways which are unable to withstand normal snow removal operations due to deterioration or substandard construction.
- Owners, tenants, guests, etc. agree not to place any obstacles in, or along side of, the driveway. If obstacles are presents, MLR Services LLC, d.b.a. Acme Snow Removal will not plow that portion of the driveway. Owners should snow stake any altered portions of the driveway, which could become invisible to equipment operators during snowy conditions or nighttime hours. Should snow removal equipment become disabled due to objects left in the residence's driveway, the contracting party signing below will be invoiced at the \$125.00 per hour equipment rate for the time that repairs must be conducted to bring the equipment back into service. The total sum billed to the homeowner is not to exceed the total costs of repairs.
- Please move cars from driveway. ***We will not come back to remove snow because of obstructions until the next scheduled snow service day.***
- MLR Services LLC, d.b.a. Acme Snow Removal is not responsible for ice, on or around driveways, snow packed by vehicles, or any accident on owner's property not directly involving Acme Snow Removal. ***Snow that unloads from roofs onto driveways and in front of garage doors is the homeowner's responsibility after Acme Snow Removal has completed the daily route.***
- If, for any reason, the contracting party wishes to cancel this agreement, MLR Services LLC will charge all previously rendered work at \$100.00 per plow (not to exceed the amount of contract), and refund the unused balance of the snow removal fee.
